Sub Shortage

We are all aware there is a serious sub shortage in this and many other districts due to the low pay and low nationwide unemployment. Please be aware that you should follow the contract about covering classes and that includes requesting payment. You can do this by completing a time sheet that can be found on GJEA website. GJEA suggests that you develop a list of teachers who are willing to give up their planning time to receive the hourly pay and when they are available. Then, the principal or their secretary know who to ask to cover during each period during the day. This list should be the first thing the principals are using not the last.

The contract states that teachers are paid the hourly wage for covering a class during their planning time for an absent teacher. Make sure that after you cover a class, you fill out a time sheet and turn it into your school's front office within 14 days. If you do not, you will NOT get paid. Again, the hourly pay form is on the GJEA website for you to download.

Negotiations

OEA Board Endorses State Issue 1

The OEA Board of Directors **unanimously** voted to endorse State Issue One, the Ohio Neighborhood Safety, Drug Treatment, and Rehabilitation Amendment. Issue 1 seeks to reduce the prison population in Ohio by reducing low level felony drug possession charges to misdemeanors. Those charged with 1st, 2nd or 3rd degree felony drug charges could still face prison time.

Issue 1 also seeks to eliminate prison sentences for probation violations if they aren't new crimes. It would reduce prisoners' sentences by up to 25% for completing work, education and rehabilitative programs while incarcerated. Finally, Issue 1 proposes to divert the money saved from reducing the prison population toward drug treatment, trauma care for crime survivors and local governments. Other key points are that Issue 1 is a choice to build new prisons, spending billions or try something new to deal with the addiction crisis. Ohio prisons are at 138% capacity and 14 Ohioans are overdosing every day.

Issue 1 does **not** eliminate prison for drug trafficking and individuals caught with larger amounts of drugs like fentanyl and could still be charged with trafficking and face prison.

"We believe that Issue 1 helps to address the urgent need to fix Ohio's broken and overcrowded prison system that puts in jail non-violent offenders at the expense of adequately funding prevention and treatment programs," said OEA President Becky Higgins. "As educators, we see the terrible impact of the opioid epidemic on our communities and the families of our students. We are there to help our students when tragedy strikes. But too often the resources for treatment are not there. Passing Issue 1 will save money that's currently misspent to lock up people with addiction problems who would be better served by getting treatment."

What is a Flexible Spending Account? (FSA)

Be aware that a FSA is an insurance program that allows you to put money into an account tax free to pay for a number of items. The program allows you to pay for such things as child-care, prescriptions, doctor visit co-pays, dental procedures and your deductible for health insurance. Please pay attention to your pay stub for information because the deadline is the end of December for the FSA beginning every January. Those of you who have had it before will need to renew as well.
