### **Tuition Reimbursement**

Did you know that Gahanna teachers are eligible for tuition reimbursement? This year, over \$100,000 will be distributed to teachers who have spent money on their continuing education from May 2, 2019 through May 1, 2020. In past years, teachers have been reimbursed for as much as one half of their tuition expenses.

Please complete the tuition reimbursement form that has been sent to you by email from Lynn Guthrie in HR. Make sure that you provide proof of payment AND proof of grade or completion from your professor. This is for tuition expenses ONLY. Associated expenses, such as travel, parking, lab fees, or insurance, are not reimbursable. Also, you must fill out the form completely, including monetary totals.

The completed form with all documents must be returned to the Human Resource office no later than May 1, 2020 at 4:00 PM. No forms will be accepted past the deadline. Please be aware that if you do not correctly follow the procedure the committee has laid out, you unfortunately will not be included in this year's allotment. If you take a course in April and are unable to procure the documentations by May 1, you may submit it next year for reimbursement.



# **NEA Directors Lobby in DC**

As a newly elected NEA Director, I attend what is known as "NEA Super Week" for training, lobbying and the NEA Board of Directors meeting. These super weeks are held about 3 times a year in Washington D.C. at NEA's Headquarters. As one of 8 NEA Directors representing Ohio, one of the most rewarding parts of the job is to visit Capitol Hill and speak with our elected Representatives, both Democrats and Republicans, on a variety of topics that relate to Public Education. One of the issues discussed on my most recent trip was "Ending Social Security Penalties GPO/WEP" which penalizes public employees (teachers included) who started working in the private sector before becoming a public employee. Because teachers collect a pension, your social security will be either eliminated or heavily reduced. If you paid into Social Security with a certain number of years, then you should be eligible to collect Social Security.

For example: Early in your marriage you decide to leave teaching because of childcare while your spouse works in the private industry. Then, you decide to return to work after your children are old enough. The unfortunate happens and you lose your spouse. You want to retire but can't because your spouse's Social Security won't cover you because you are eligible for STRS. OEA and NEA are lobbying for an end to this unfairness.

Another topic we spoke with legislators about is "School Modernization/Rebuild America's Schools Act" which encourages the Federal Government to take notice and help public schools replace or renovate buildings. The average school building is 50 years or older and many of them are unhealthy for our students and teachers. The infrastructure of schools nationwide are in poor shape and in Ohio, we fit the trend. We placed copies of pictures from buildings with the awful conditions that our students and teachers are in every day (Gahanna included) in the hands of each Congress person we talked to.

Being a NEA Director, I am able to bring our local issues directly to Washington D.C. and I am proud and honored to represent Gahanna and Ohio so I can place our issues on the forefront. Our next "NEA Super Week" will be in April.
