Two School Funding Bills may be introduced

The Fair School Funding Plan includes an additional \$720 million over Fiscal-Year 2019 levels for local school districts. Under this plan, no school district will receive less funding and will base funding on identifiable student needs. It will increase funding for most school districts including Gahanna-Jefferson over the next two years. It provides direct funding for charter schools meaning Gahanna will no longer lose property tax revenue to charter schools. In fact, Gahanna would be able to retain over \$2 million if this bill was to pass in addition to an increase in state funding. Right now, about 70 school districts would not see an increase but the legislation continues to work to solve this dilemma. *OEA is strongly in support of this plan*.

House Bill 166 is the state budget bill for fiscal years 2020 and 2021. It includes Governor DeWine's school funding proposal. An additional \$550 million would be provided over the biennium, outside of the formula, to support disadvantaged students by providing wraparound services, mental health counselors, physical health care services, mentoring, professional development when trauma-driven care may be required and other means of addressing student needs. The problem with this bill is that it continues to allow Charter School to take funding from local school districts and make it easier for school districts to be taken over by the State. Even though OEA supports the funding this plan offers which includes funding for wraparound services, the problem could be very dangerous for school districts.

Legislation

House Bill 154 was introduced by State Representatives Joe Miller (D-Amherst) and Don Jones (R-Freeport) who are both former teachers. This bill will repeal the failed state takeover law and restore



local control to school boards. The State government has already taken away local control from Youngstown, Lorain and East Cleveland school districts. In the next two years, state government may take away local control from Dayton, Columbus, Canton, Mansfield, Lima, Toledo, Ashtabula, Euclid, North College Hill and Painesville. Please call, email or text your local representatives to support this bill and do away with Academic Distress Commissions. Support Local Control for Our Public Schools because that is why we elect our board of education.

Lobby Day by Bobby Swartzentruber

Last Tuesday was OEA's annual lobby day. This is a day in which educators can meet with their state representatives to discuss important topics in education and share personal stories. During my time with fellow Gahanna colleagues, Sarah Hanson, Dwayne Marshall, and Jenny Palguta, I had the opportunity of having very candid conversations about testing, school funding, and the "academic distress commission", which allows the state to take over failing districts.

I left lobby day with some optimism. After meeting with the offices of Rep. Lightbody, Rep. Crawley, Rep. Kent, and Rep Brown, it appears that there is movement toward the reduction of mandated testing. The first changes we will likely see are is a recommendation that the SAT/ACT become optional. As for End Of Course exams, Ohio is significantly above the federal minimum, so we discussed the impact this has on students, teachers, and the school day. Several representatives gave the impression that they would be willing to cosponsor some legislation to address this. Any teachers who would like to share their testing stories during possible future committee hearings should contact Jenny as she is collecting stories about Gahanna students.

Other legislation that we should put our support behind is the "Fair School Funding Plan". This would increase state funding by \$720 million for (FY) 2019. The plan also eliminates "school district pass-through deduction." This means that charter schools would be directly funded instead of local districts being stripped of funds. For this past year, it would mean approximately \$2 million in additional funding for Gahanna (that would not leave the district). This, by no means, is a done deal. There are competing ideas about funding, as well as budget language that is less than ideal. OEA will continue to lobby on our behalf and work toward fair and equitable funding for all public schools.

More representatives on both sides of the aisle are listening to the voices of educators. They are hearing our frustrations. There are some positive signs that the DeWine administration is willing to make changes that would benefit public education as well. It is important that we continue to engage our elected officials. Each emphasized that their doors are always open for discussion and that they would like to hear stories from our classrooms.

Tuition Reimbursement

Did you know that Gahanna teachers are eligible for tuition reimbursement? This year, over \$100,000 will be distributed to teachers who have spent money on their continuing education from May 2, 2018 through May 1, 2019. In past years, teachers have been reimbursed for as much as one half of their tuition expenses.

Please complete the tuition reimbursement form that has been sent to you by email from Lynn Guthrie. Make sure that you provide proof of payment AND proof of grade or completion from your professor. This is for tuition expenses ONLY. Associated expenses, such as travel, parking, lab fees, or insurance, are not reimbursable. Also, you must fill out the form completely, including monetary totals.

The completed form with all documents must be returned to the Human Resource office no later than May 1, 2019 at 4:00 PM. No forms will be accepted past the deadline. Please be aware that if you do not correctly follow the procedure the committee has laid out, you unfortunately will not be included in this year's allotment. If you take a course in April and are unable to procure the documentations by May 1, you may submit it next year for reimbursement.

PLEASE NOTE: LEGALLY, INDIVIDUALS WHO ATTENDED THE SUMMER INSTITUTE FOR GRADUATE CREDIT AND RECEIVED THE HOURLY PAYMENT ARE NOT ELIGIBLE FOR TUITION REIMBURSEMENT.

Public Health Administrator, Department of Addiction and Drug Services, Columbus Public Health

Ms. Boxill will discuss the disease of addiction, what the specific disease of opioid use disorder is and how it impacts a child. She will also provide resources on developing a team to address the multi-systemic needs of the child and family.

Kim Kehl, M.Ed.

Medical Director, Ohio Departments of Mental Health and Addiction Services
