Do you have a question about your teaching license? Will you need to renew your teaching license in 2015? All licenserelated questions can be answered by our Local Professional Development Committee (LPDC), with all related information now located on the GJPS Staff Intranet. Just look in the left column and scroll down to "Human Resources." Then click on the "LPDC" link. All current LPDC forms including IPDP and CEU requests are now located at this site. Legislation

There are a number of bills in the Statehouse that will affect the education profession. House Bill 228 will limit the number of hours a student can be tested in one year per subject to four hours. House Bill 642 places a 3-year suspension of high stakes testing. Other items: House Bill 343 that will eliminate Common Core has made it out of committee and will be voted on by the State House. It is believed that if this bill passes the State House, it has no chance of passing the Senate. Also, STRS, SERS and PERS have worked out an agreement that will allow transfer of credit. The legislators still have to accept the proposal, which is ex-

- * You may take them in whole or half day increments.
- * They do have the right to deny your leave if there are more than 25 teachers out on a Friday or a Monday.
- * You may not use it against a holiday unless you give a good reason. Please

email Matt Cygnor and explain why you need personal leave if it falls against a holiday. He has the authority to grant the day.

Finally, you "will receive an incentive for not using personal days in a given school year: \$150 for one day not used, \$250 for two days not used, and \$350 for three days not used, payable in the second July pay."
