Evaluation Update

The continued tion to be times sometimes sometimes.

The district's Evaluation Committee has been meeting (five times so far), and is

currently working to approve all SLO's. The committee's work has been a very cooperative and collaborative venture between the administrators and the teachers. Any evaluation questions that cannot be answered by your own evaluator may be directed to Scott Schmidt (CO) or to GJEA President Jenny Palguta (MSS).

Will the new over-the-top teacher evaluation system in Ohio actually be getting some improvements? Maybe. In last summer's budget bill, the Ohio Senate included language to reduce the value-added component from its current 50% of a teacher's evaluation to 35%. But the Ohio House -- under orders from Governor Kasich -- stripped it out.

Now, Senator Randy Gardner (R-Bowling Green) has introduced SB 229, which once again seeks to make Ohio's Teacher Evaluation System (OTES) a fairer process. Our OEA officers believe that SB 229 would make Ohio's new evaluation system more effective, fair, and efficient by reducing the academic growth factor and allowing school districts to reduce the frequency of evaluations for highly rated teachers. The OEA strongly supports SB 229 as part of ongoing efforts to address various concerns with OTES.

SB 229 proposes the following changes to Ohio's teacher evaluation system:

Academic growth factor: Lowers the academic growth factor percentage required on teacher evaluations to 35% from the current 50%. A school district may attribute an additional percentage to the academic growth factor not to exceed 15% of an evaluation. The academic growth factor under the OTES is based on value-added and/or other student growth measures, depending on the subjects and grades in a teacher's course load.

Frequency of evaluations: Authorizes local school boards to reduce the frequency of evaluation required for teachers who receive an evaluation rating of "Skilled" or "Accomplished" (the top two ratings).

A school board may evaluate each teacher rated "Accomplished" on the teacher's most recent evaluation once every three school years. Currently, a board may elect to evaluate an "Accomplished" teacher once every two years, instead of annually.

A school board may evaluate each teacher rated "Skilled" on the teacher's most recent evaluation once every two years. Currently, a board is required to conduct annual evaluations for teachers rated "Skilled."
